Cancellation policy:

If you wish to cancel a confirmed booking you must let us know as soon as possible in writing. Your booking will be cancelled with effect from the day we receive your written notification.

- Mooring fees are refundable less a £10 admin fee, until 4 weeks prior to the event.
- Between 2 - 4 weeks prior to the event a 50% refund less a £10 admin fee will be issued.
- From 2 weeks prior to the event no refund will be issued.
- Once a booking has been accepted by Cowes Harbour Commission it can only be changed to either another mooring or different dates by treating the original booking as a cancellation. Please refer to applicable cancellation terms above.
- **Cancellations by Cowes Harbour Commission**
If, due to circumstances beyond our control, the customer's booking is cancelled, the customer shall be refunded the full amount of the booking in an equal amount to time remaining. We cannot, however pay any compensation or expenses as a consequence of such an event.

Signing this form indicates:

- I have read and agreed to the Shepards Marina Terms of Business.
- I understand that my booking is not confirmed until full payment is received and a confirmation email sent.
- I understand fees are refundable less a £10 admin fee, until 4 weeks prior to the event; after this date the cancellation policy applies.
- In the event that I fail to pay the amount on the due date, Cowes Harbour Commission has the right to cancel this request for a mooring and allocate the mooring to another applicant.
- Should I remove the vessel part way through the stay, the full stay charge applies, no part stay discount is available.
- The berth allocated under the agreement is for the named boat only. Any other boats supplementary to the named boat will be treated as a separate booking; this includes RIBs and tenders.
- Cowes Harbour Commission will aim to accommodate specific mooring location requests, however, there is no guarantee that all requests will be met. Final mooring allocation decisions are final and solely at the discretion of Cowes Harbour Commission.
- I understand that I or any of my crew must not alter/adjust (add to or remove) the strops for the swinging mooring or use the strop in any other way than intended. Any attempt to do so will result in the mooring space being adjusted and could cause damage to your or adjacent vessels.
- The vessel using the mooring is to be insured for recovery and removal from the harbour in the event of sinking. Such insurance shall be for a minimum of £2,000,000 in respect of public liability and third party liability cover.
- It is the skipper's responsibility to monitor the weather and be prepared, if necessary, to move the boat if conditions deteriorate.
- Should I require work to be completed on the vessel during the stay I understand the following:
All outside contractors working the vessel must be approved by CHC in advance, and be fully insured, including third party liability insurance.
Where welding or hot works are to take place on the vessel, as per Cowes Harbour General Direction 4.7, the contractor or I will seek permission from Cowes Harbour Commission before the work proceeds.
Cowes Harbour Commission does not accept any responsibility for contractors working on the vessel.
It is my responsibility to ensure that a 'diving request' is completed and forwarded to Shepards Marina/Cowes Harbour Office at least 24 hours before any diving operations, as per Cowes Harbour General Direction 4.5. Approval must have been received and a radio check completed with call sign 'HM1 on VHF Ch69' for activities outside of the confines of Shepards Marina or on VHF Ch80 with Shepards Marina Office immediately before the diving operation commences and a diver enters the water.
- I understand Cowes Harbour Commission accepts no liability for any loss, damage or costs of whatsoever nature suffered by me except to the extent that such operation is caused by the negligence or wilful act of Cowes Harbour Commission or those for whom the Commission is responsible.
